Limited Warranty

Warranty Terms and Conditions:

All STAY-TUFF Fence wire products with a Class 3 galvanized coating; including fixed-knot fence, stiff-stay fence, hinge joint fence, electric fence wire, and barbed wire purchased from an authorized dealer or contractor are warranted to the original purchaser for a period of twenty (20) years from the date of purchase. The warranty will provide coverage against defects in material and workmanship. Normal wear, tear, abuse, and/or misuse are not covered by the warranty.

Prompt notification shall be given to STAY-TUFF Fence of any defective product. STAY-TUFF Fence agrees to repair or replace at its option any goods covered by this warranty within 30 days of such notification. This limited warranty is provided to and only applies to the consumer who originally purchased the product from a STAY-TUFF authorized dealer or contractor.

Please read the following instructions carefully. This **Warranty is void** under the following conditions:

- In the event that the fence is installed other than strictly in accordance with the manufacturer’s guidelines.
- If the product is used for any purpose than as a fence.
- If any product defects arise from conditions or use other than those considered to be normal working conditions. Misuse and damage by flood, fire, or acts of God are not covered by the warranty.
- Damage on installed products at locations within 20 miles of the coast.
- Damage sustained while in transit or on the merchant’s premises.
- If the Warranty Registration Card is not completed and returned to STAY-TUFF Fence within 60 days of purchase date, together with one original product label for each fence specification purchased, plus a copy of your purchase receipt.

This warranty does not cover any consequential loss, attorney’s fees, or damage howsoever arising and is strictly limited to the value of the product supplied excluding freight, removal, and installation charges. (Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you).

This warranty gives you specific legal rights and you may also have other rights which vary from State to State.
